LONG TERM AGREEMENT FOR THE PROVISION OF Information Technology and Office Equipment and After Sale Services for UNDP/PAPP office in Jerusalem and its various funded Projects in West Bank and for the Offices of the other UN Agencies

This Long Term Agreement is made between the United Nations Development Programme, a subsidiary organ of the United Nations, having its Offices at 4A Yaqubi Street in Jerusalem (hereinafter "UNDP") and M/S **Computer Media Center CMC** (hereinafter called "Supplier") with its Headquarters at Jerusalem.

WHEREAS, UNDP desires to enter into a Long Term Agreement for the provision of Goods and Services by the Supplier to UNDP, as provided herein;

WHEREAS pursuant to the Invitation To Bid dated 23 March 2011, the offer of the Supplier dated 19 April 2011 was accepted;

NOW, THEREFORE, UNDP and the Contractor (hereinafter jointly the "Parties") hereby agree as follows:

Article 1: SCOPE OF WORK

1. The Supplier shall provide the types of Goods and Services, which are listed in Annex A hereto ("The Price List").
2. Such Goods shall be at the PRICE LIST in Annex A. The prices shall remain in effect for a period of ONE year from Entry into Force of this Agreement.
3. UNDP does not warrant that any quantity of Goods will be purchased during the term of this Agreement, which shall be for one year.



Article 2: CHANGES IN CONDITION

In the event of any advantageous technical changes and/or downward pricing of the Goods during the duration of this Agreement, the Supplier shall notify UNDP immediately. UNDP shall consider the impact of any such event and may request an amendment to the Agreement.

Article 3: CONTRACTOR'S REPORTING

The Supplier will report semi-annually to UNDP on the Goods and Services provided to UNDP or other UN agencies utilizing this agreement.

Article 4: GENERAL AND SPECIAL TERMS AND CONDITIONS

The standard UNDP General Conditions of Goods, attached as Annex B, shall apply to this Agreement, and any subsequent contracts concluded in accordance with paragraph 1 above.

Article 5: ACCEPTANCE

This Agreement supersedes all prior oral or written agreements, if any, between the Parties and constitutes the entire agreement between the parties with respect to the provision of the Goods hereunder.

This Agreement shall enter into force on the date of the last signature by the representatives of the Parties and shall remain in force for a period of one year, and may be extended for two additional years by mutual agreement of the Parties.

IN WITNESS WHEREOF, the duly authorized representative of the PARTIES has signed this agreement.
